Sealed Bids for the construction of the Sanitary Sewer & Water System Improvements To Serve Brimberry Street will be received, by the City of Camilla, at Camilla City Hall – 30 East Broad Street, Camilla, GA 31730, until 10:00 AM local time on February 28, 2019, at which time the Bids received will be publicly opened and read. The Project consists of construction of +/- 600 LF of 6" PVC Water Main including fittings, valves, fire hydrants and services, along with the construction of +/- 560 LF 10" gravity sewer main, +/- 20 VF of standard/interference manhole construction, transfer of existing sewer service connections, and replacement of 4" PVC sewer service from main to right-of-way, including abandonment and all other items indicated in these Contract Documents.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, as indicated in the Bid Form.

Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Bid security shall be furnished in accordance with the Instructions to Bidders.

All permits required for the construction of this project are expected to be approved prior to the date of the bid opening.

Acquisition of property for easements and/or right of way is not expected to be required for this project.

This project is expected to be funded by local funds.
